

Who we are

Live Music Now is a charity working and campaigning to create inclusive, measurable social impact through music. By harnessing the power of music and evaluating its impact, we advance musical practice and change how we understand and support underrepresented and vulnerable people in our society. Our work has been shown to enhance health and wellbeing, building skills and confidence and increasing engagement and equity of opportunity by recognising the potential of every individual.

We work with over 300 professional musicians, connecting them with older people, children and young people facing disabling barriers, families living through challenges, and carers and key workers supporting others. Through engaging experiences, our musicians inspire and support people to live musical lives and to find happiness through liberating musical encounters creating life-affirming memories.

Live Music Now was founded in 1977 by musician Yehudi Menuhin and philanthropist Sir Ian Stoutzker, with a belief that everyone has a right to live fulfilling musical lives. Today Live Music Now's work is underpinned by research, cross-sector partnerships, advocacy and the professional development of musicians across England, Wales, Northern Ireland and in the international community. With an impact far beyond its scale, the organisation has deeply embedded itself in the UK music & culture and arts & health sectors.





Organisational Structure

Live Music Now's organisational structure was conceived as a branch system, featuring local boards and management teams. Whilst this has enabled the development of regional and local partnerships, it also prevents us from capturing the opportunities available when we work as a more cohesive organisation.

Over the summer of 2024 we will be moving to an organisational structure led by our strands of work

- Music in Education
- Music in Health
- Music in Place

whilst maintaining distinct national offices.

This newer setup enables us to encompass the independent priorities, demographics and needs that England, Wales and Northern Ireland have. We look to our national offices to develop strategic aims aligned with the devolved governments and deliver bespoke national strategies that feed into the UK-wide agenda, alongside initiatives developed with our sister organisation Live Music Now Scotland. Live Music Now is unique as a national organisation working across all life states using music for social change in the breadth of programmes and research that we deliver.

We are however, still a relatively small organisation, especially against the enormous landscape of need for our services. The current restructure of the organisation will help us to define our expertise, drive cutting-edge research, and share that knowledge across the whole sector. This will enable us to support other independent organisations, freelance musicians, and people across the UK, setting the standards around quality of provision across the whole sector.

We will continue to collaborate with the international branches of Live Music Now and seek opportunities for our musicians and our communities to be connected on the global stage.

What we are looking for in potential Trustees

Live Music Now UK has a central Board of Trustees, chaired by Sir Vernon Ellis, which oversees the governance and core strategic activities of the charity in England, Wales and Northern Ireland (Scotland has its own Board), and there are sub-committees covering Finance and Risk, Remuneration, and Nominations. Some of our Trustees also sit on the national advisory boards: each national office is led by a member of senior management and supported by a national advisory board.

Live Music Now has a deeply committed team of musicians and staff, who deliver thousands of meaningful and impactful activities each year. We are seeking Trustees who can contribute skills, time, and energy, helping to develop our work and bring new insight alongside robust governance. This includes those with a range of skills including lived experience alongside professional expertise.

We are particularly looking for Trustees with skills and experience of:

- Finance (including chairing the Finance and Risk Committee in due course)
- Legal
- Professional musician
- Health sector
- Northern Ireland (including chairing the Northern Ireland advisory committee)

- An understanding and acceptance of the legal duties and responsibilities of being a Trustee.
- Good judgement.
- Supporter of music and arts in wellbeing.
- An ability to think creatively and strategically.
- An ability to collaborate and work as part of a team.
- Effective communicator with strong interpersonal skills.
- A commitment to equity, diversity, and inclusion.
- A willingness to devote the necessary time and effort required (this is around 6 to 8 days per year)

What We ask

- You agree to serve an initial term of four years, with the possibility to extend to a second and third term.
- You are able to attend four Board meetings a year as well as an annual strategy workshop (we alternate between in-person and zoom for our Board meetings, normally 3-4 hours in length and in the afternoon.
- Board papers must be read in advance of meetings.
- You attend a small number of workshops and events in your area over your term.
- You join and attend meetings of Board subcommittee/s
- That you will provide specialist advice to the SMT as required

Trustee roles are voluntary and therefore unpaid, however reasonable out-of-pocket expenses can be covered.

- Supported induction to the Live Music Now Board
- the opportunity to support and work alongside a dedicated, knowledgeable and passionate staff team

- A brief covering letter (up to 3 A4 pages) OR a short video of yourself (no more than 5 minutes), detailing why you're interested in becoming a Trustee and what you would bring to the role.
- Your CV (no more than two A4 pages)

The deadline for applications in this phase is **9am on Monday 9**th **September**.

This is a rolling process, and we will be reviewing applications as they come in. Those fitting our specifications will be invited to meet with the Chair and our CEO, and/or other Trustees from our Nominations Committee.

These conversations will take place as required, likely in August and September; we will notify you either way if you have been selected for interview or not. Your application will then be put to the Board for approval in our October meeting.
